As the seat of Humboldt County, Eureka is located 270 miles north of San Francisco, CA and 100 miles south of the Oregon border. Eureka is in the heart of the Redwoods and approximately 2 miles from the Pacific Ocean, offering quality rural living with outstanding outdoor recreation activity year round. The community has an excellent primary and secondary educational system; College of the Redwoods, a community college, is located 10 miles south, and Cal Poly Humboldt is located 8 miles north.
